Rich Tschirgi-Inland Empire Wrestling Officials: Any cancelations/changes Rich needs to be the first call. Figure 4 is an illegal move this year. Tournament fee has not changed. Dual meets have gone up by \$4. Medical form, the only one that they will accept is the one on the WIAA website. Form is good for two weeks. Braces (teeth) must be covered by official mouth guard. No nude weigh in. New weight classes, dramatic change in the girls. If officials believe that the wrestler has a concussion, they will instruct the coach to evaluate, they will not diagnose a concussion. If it still seems unsafe they will end the match. District 7 Report-Russ Brown

- 1B Volleyball @ Yakima D4#1 Kings Way Christian played one too many games and are not allowed into post season. WIAA sent out the update on 11/8.
- Football—1B will use home association officials because this isn't first round of state for 1B, 2B will have split crew 3/2 home/away officials. Prices are \$8/\$6, use common sense with young kids. No special passes. 1B will not have an alternate official. Game manager \$130. Collect money, fill out financial form, list expenses, and send profit to Russ. Russ will pay all officials. Teams can bring/use their own heater on the sidelines. Each school will have equal film booth. Second round games will be in Spokane. Depending on how many that will determine location. Gonzaga Prep is reserved for (1) Friday and (3) Saturday. West Valley is the backup location. Semi-Finals will be at EWU with Joe Albi being the back-up. Problems at EWU last year have been addressed.
- Hardwood Classic—Draw criteria has two questions: 1) All teams are eligible to play any other of the 8 teams. Home teams will be drawn 1-4; visiting teams will be drawn 4-1. 2) The two teams that qualify from each regional will be drawn into opposite brackets. Home teams will be drawn 1-4; visiting teams will be drawn 4-1.

Basketball: Valley Christian will not have a HS girls JV basketball team.

St. Michaels will not have a HS Boys JV basketball team.

Wilbur-Creston will be writing an amendment addressing the limit of 14 players that can suit up in a night if 8th graders are used. The amendment will strike the 14 and replace it with 16. This would allow varsity to carry 8 and JV to carry 8 if the school chooses to split it in that manner.

O-H is looking for one HS girl's basketball game.

Valley Christian is looking for one HS boy's basketball game.

Baseball: Curt handed out a proposed calendar and will put together two schedules. There are still questions about what teams will be playing baseball. Wellpinit, Inchelium and Columbia may not have teams.

Softball: District 7 is not forced to glue with District 9 this year. Motion by Pauls/Raynor not to regionalize with District 9 for softball—APPROVED. Charlie will talk to Bob Kirk about this.
